Hold Harmless Agreement / Release of Liability Waiver

Must be signed and returned before joining the orchestra or attending rehearsal

The undersigned parent/musician indemnifies and agrees to hold harmless the Livermore-Amador Symphony Youth Orchestra, the Livermore-Amador Symphony Association Board of Directors, officers, instructors, agents, and assigns from any and all liability whatsoever, for any damage or injuries, and from any and all claims and demands, including attorney fees, arising out of the party's participation in the orchestra, classes, workshops, performances, and other related activities provided for members of Livermore-Amador Symphony Youth Orchestra.

The undersigned parent/musician understands that students/musicians may occasionally appear in promotional performance videos, photos, and other materials as a result of their association with Livermore-Amador Symphony Youth Orchestra. By registering for the orchestra, such use of the student/musician's name and likeness are agreed to and acknowledged and, accordingly, all rights, title and interest in same are waived.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the LASYO and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the LASYO may result from the actions, omissions, or negligence of myself and others, including, but not limited to, LASYO employees, volunteers, and other students and their families.
